Fire hydrant survey is finished.

Attwood lift station had a major failure (3<sup>rd</sup> time it has failed)

Flowmeter meter needs to be replaced. The cost will be approximately \$6,400.

1. Submittal of Work Orders for approval

Manhole check needs to be done. Inframark will do that for \$125 per manhole.

Another company will do it for \$150. Phase 3 needs to be completed.

B. Authorize appropriate action.

Darrell Boeske made a motion to complete Phase 3. John Dagleish second the motion. The motion carried unanimously.

Darrell Boeske made a motion to approve \$6,400 for the Bond account pending legal approval for the flow meter to be replaced. . John Dagleish second the motion. The motion carried unanimously.

Jacob Floyd with Langford Engineering said that the Emergency Preparedness Plan needs to be done by March. Darrell Boeske made a motion to get the EPP done. Donnie Marshall second the motion. The motion carried unanimously.
