#### 1. Call to Order and Welcome Guest

### 2. Approval of Consent Agenda Items

Jeff Measamer made a motion to accept the minutes of the meeting. John Daglesih seconded the motion.

### B. Financial Report

3. Discussion on Lift Stations

There has been a repair of the Castle Harbor lift station. Green Pumps rebuilt the electrical panels. The pumps now pumping are 10amp pumps.

The lift stations need repair and/or replacement. Jeff Measamer would like to get 2 engineering companies to do a study on all the lift stations and give bids for work to be done. John Dagleish made a motion to proceed with this study. Ed Kile seconded the motion. The motion unanimously.

4. Discussion about possible Bond issuance.

5. Update on FEMA application for damages from the June Hurricane.

Roy Knapp discussed the guidelines that FEMA wants.

They will need more information and documentation.

One of the Board members asked "How many more meters needed to be changed out?" It was reported that approximately 80-90 more.

There was discussion about the "extra meter" that was requested at 5385 FM 980. The District will add an extra meter next to the existing meter. John Dagleish made a motion that the District install the meter, but the customer will be responsible for anything else. Ed Kile seconded the motion. The motion carried unanimously.
